2.0 OBJECTIVE

This ITQ is neither a contractual offer nor a commitment to purchase any products or services. All information contained in the quote must be legible. Any and all corrections and erasures must be initialed. **Each quote shall be signed in ink by an authorized representative of the respondent.** The contents of the quote submitted by the successful respondent of the ITQ may become part of the contract awarded as a result of this solicitation.

2.1 SCOPE OF WORK (SOW)

The Scope-of-Work ("SOW") contained in the Attachments describes the services expected for a Contractor to provide the STOFHD. Respondent must ensure that all such services contained in the SOW are provided for in every particular and shall meet or exceed the level of quality, availability, features, functionality, frequency, accuracy, and performance.

The silence of specifications or requirements as to any detail contained in this document or any of the attachments or exhibits, or the apparent omission from any specifications or requirements, or a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices shall prevail and that only material and workmanship of the finest quality are to be used. All interpretations of the Scope of Work shall be made on the basis of this statement.

2.3 NOTIFICATION

Each respondent submitting a quote in response to this ITQ will be notified in writing as to acceptance or rejection of their quote. Release of notification letters should be within sixty (60) days of the quote submission date. STOFHD reserves the right to delay this action if it is deemed to be in the best interests of STOFHD.

General Notes:

- Schedules must be submitted with all bids and updated any time there is a change
- Contractors are expected to work Monday-Friday, 8:00am-5:00pm unless otherwise specified by the project manager
- All materials being installed shall be of equivalent make/model to the original material being removed. (Unless it has first been approved by the Housing Department)
- All work performed shall be as per code(s).
- **Schedule of Values and proposed Schedule shall be submitted with proposals.**
- Supply all drawings/prints and any other documentation needed by the Building Department.
- Clean up jobsite daily and before the final inspection of the completed job.
- Call the Building Department & Housing Department for all inspections, before and during the installation process. (Jacqueline Kaegi 863-623-7476)
- Contact Housing Department for final inspection, prior to leaving the jobsite

Section 3: Specific Scope of work – Updated Windows with Shutters alternate Impact Windows

- From the interior of the home score the paint, pull out jam and remove older, existing windows (8) keep the remaining windows that are in good condition
- Insert new double pane, low-E insulated glass, energy efficient windows with similar window-panes and install awnings (Exterior)
- Apply window caulk around perimeter (interior and exterior) seal any gaps and weather flashing to prevent leaks – Waterproof the windows
- Ensure windows are all squared, leveled with shims as well as replace windowsills and interior trim around the interior of windows
- Alternate pricing – remove older, existing windows (8) and install impact hurricane-related windows
- Contractor must field measure all windows for accuracy before ordering (Measure window top, bottom and diagonally from corner-to-corner via inside)
- Remove and dispose debris from the job site daily; keep a clean job site
